<b>What is the overall <a href="#">deductible</a>?</b>	For <a href="#">in-network providers</a> : \$500/individual or \$1,500/family For <a href="#">out-of-network providers</a> : \$1,000/individual or \$3,000/family	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. In-network <a href="#">preventive care</a> & immunizations, office visits, out-of-network inpatient hospital facility, out-of-network outpatient hospital facility, emergency room visits, in-network <a href="#">urgent care</a> facility visits.
